## INVITATION TO SUBMIT PROPOSAL ON TRASH SERVICES

Hardin County CUSD #1 is soliciting proposals for trash collection services at our K-12 facility located two miles east of Elizabethtown on Route 146. Interested parties should submit a bid for a one year proposal and a separate bid for a two year proposal. Proposals should be for at least two 6 yard containers and one 8 yard container.

- 1. Containers & service must be available by July 15, 2023.
- 2. Containers (with lids) should be placed at two locations located at the rear of the building.
- 3. Containers should be kept in good repair (painted, etc.) as determined by the Superintendent. Contractor shall have the responsibility for upkeep of containers.
- 4. Contractor shall empty containers at the same scheduled day weekly unless prior approval is granted by the Superintendent.
- 5. Containers must be emptied at least twice per week.
- Year #1 service will be from July 15, 2023 July 14, 2024;
   Year #2 service will be from July 15, 2024 July 14, 2025;
- 7. Trash must be hauled to a landfill approved by the State of Illinois.
- 8. At all times contractor must observe and comply with all laws, ordinances, regulations and codes of the federal, state, county and other local government agencies, which may in any manner affect the performance of the contract.
- 9. Payment to contractors will be made monthly over 12 months each year.
- 10. District reserves the right to terminate service to any contractor that the district believes fails to carry out the terms of this proposal satisfactorily.

Proposals must be returned to the District Office by 2:00 P.M. on June 26, 2023. No late bids will be accepted. The bids will be opened at the regular board meeting held June 26, 2023.
